This community discussion will solicit public comments on local priority needs that will guide the preparation of the City of Roseville's 2024 Annual Action Plan; the meeting will also discuss the 2024/25 application for CDBG and HPRR funding. The City anticipates receiving approximately \$700,000 in CDBG funding in 2024/25, with an estimated amount of \$560,000 available for program and project awards. The City has approximately \$619,000 in Homeless Prevention Rapid Rehousing (HPRR) funding available to be utilized in Roseville and Rocklin.
