CONDITIONS:

Permittee agrees to all the terms and conditions of this permit, including all provisions on this form and any attachments.

Permittee waives all claims against the City of Roseville, its officers, agents and employees, for loss or damage caused by, arising out of or in any way connected with the exercise of this permit and Permittee agrees to save harmless, indemnify and defend the City of Roseville, its officers, agents and employees, from any and all loss, damage or liability which may be suffered or incurred by the City of Roseville, its offices, agents and employees caused by, arising out of or in any way connected with exercise by Permittee of the rights hereby permitted, except those arising out if the sole active negligence of the City of Roseville.

The City of Roseville shall have the privilege of inspecting the premises covered by this permit at any or all times.

The City of Roseville may terminate this permit at any time if Permittee fails to perform any covenant herein contained at the time and in the manner herein provided. The City of Roseville agrees it will not unreasonable exercise this right of termination. Permittee shall promptly obey all reasonable orders of any Roseville police, fire, building or code enforcement of official during the term of this Permit. Failure to do so obey shall be ground for immediate termination of this Permit.

The parties hereto agree that the Permittee, its officers, agents and employees in the performance of this permit shall act in an independent capacity and not as officers, employees or agents of the City of Roseville.

No alteration of variation of the terms of this permit shall be valid unless made in writing and signed by the parties hereto.

Permittee will not discriminate against any employee or applicant for employment because of race, color, religion, ancestry, sex, age, national origin or physical handicap.

Permittee agrees to comply with the terms and conditions contained in the attached Exhibit(s), which term and conditions are by this reference made a part thereof.

The Permittee hereby agrees to comply with all the rules and regulations of the facility or institution subject to this permit.

This permit shall not be assigned. Permit must be kept on site at all times.

Film location credit for the CITY OF ROSEVILLE would be greatly appreciated.

RISK MANAGEMENT DIVISION INSURANCE REQUIREMENTS FILM PERMITS

Proof of insurance must be provided on a CERTIFICATE OF INSURANCE. This document must be signed, a stamped signature will suffice. The Additional Insured Endorsement or section of the policy showing the City as an additional insured must accompany the Certificate of Insurance.

Type of Insurance Required:

General Liability

Limits of Coverage:

\$1,000,000 per occurrence

\$2,000,000 aggregate

Personal Injury:

\$1,000,000 per occurrence

Additional Insured Required:

The City of Roseville, its agents, officers and employees must be named as an additional insured on the policy. A separate endorsement (CG2026 preferred) or section of the policy indicating the City of Roseville is an additional insured <u>must</u>

accompany the Certificate of Insurance.

A statement on the Certificate WILL NOT suffice.

Certificate Holder:

The Certificate Holder is "The City of Roseville, Attn Risk Management, 311 Vernon St., Roseville,

CA. 95678"

Primary Insurance:

The coverage must be primary insurance as to the City of Roseville. Companies issuing such policies shall be liable up to the total amount of liability without right of contribution from the City of

Roseville or its insurers.

Description of Operations:

The event information (i.e., facility description, date

of event, etc.).

Cancellation Notice:

The City requires a 30-day cancellation notice.
