RESOLUTION NO. 21-280

ADOPTING THE URBAN WATER MANAGEMENT PLAN AND AUTHORIZING STAFF
TO SUBMIT TO THE CALIFORNIA DEPARTMENT OF WATER RESOURCES

WHEREAS, the Urban Water Management Plan Act requires every urban water supplier providing water for municipal purposes to more than 3,000 customers to develop and submit an Urban Water Management Plan (UWMP) every five years to the California Department of Water Resources (DWR); and

WHEREAS, with ongoing and recent updates to the DWR Guidebook for Urban Water Suppliers, staff collaborated with a consultant on the development of the 2020 UWMP update; and

WHEREAS, the City has prepared and circulated for public review the UWMP, and a properly noticed public hearing regarding said Plan was held by the City Council on June 16, 2021.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Roseville that the UWMP is hereby adopted and ordered filed with the City Clerk; and

BE IT FURTHER RESOLVED that the Mayor is hereby authorized and directed to file the UWMP with the California Department of Water Resources within 30 days after this date.
