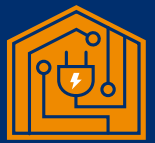

PROGRAM REQUIREMENTS:

- Qualifying Induction Cooktops must be 30" or larger.
 - Photographs are required showing the 'before' cooktop and the 'after' induction cooktop.
 - Portable/Counter top induction cooktops are not eligible for rebate.
- The Heat Pump Clothes Dryer must be **ENERGY STAR**® certified.
- The panel replacement must include circuits dedicated to the following:
 - Level 2 EV Charger
 - Heat Pump Water Heater
 - Heat Pump HVAC
 - Induction Cooktop
 - Heat Pump Clothes Dryer
- Electric Panel replacement rebate may be used for labor and material costs.
- EV Ready Requirement for Panel Replacement Rebate - For all panel replacement projects a 240 volt plug must be installed in or near the garage if one is not already installed.
